

LOCAL ELECTION ORGANIZATION TIMELINE

AUGUST 2020

Establishment of provincial (aimag) and capital city election committees	<p>The Citizen's Representative's Assembly (Hural) shall create provincial and capital city election committees each consisting with a chairman, secretary, and five or seven members and announce it publicly within no less than 70 days before the election day.</p> <p>(Article 16.1 of the Local Election Law)</p>	Before 06 th August 2020
Establishment of soum and capital city district election committees	<p>The aimag and capital city election committee shall create soum and capital city district election committees each consisting with a chairman, secretary general, and three or five members and announce it publicly in its territory within no less than 60 days before election day.</p> <p>(Article 17.1 of the Local Election Law)</p>	Before 16 th August 2020
Suspension of the transfer/migration of citizens	<p>Transfer/migration of citizens from one administrative unit to another administrative unit shall be suspended from 16th August 2020 and resumed the next day after the election day.</p> <p>(Article 24.1 of the Local Election Law)</p>	Suspension shall begin from 16th August 2020 and resume from 16 th October 2020
Delivery of citizens' of eligible voting age data in paper and electronically by respective authorities	<p>The following organizations shall submit citizen's father's name / and/or mother's/, first name, citizen identification card number, date of birth, gender and other necessary information to the General Election Commission 60 days prior to Election Day by paper and electronically.</p> <ul style="list-style-type: none"> - The Supreme Court shall submit information of eligible voting citizen's whose legal incapability is proven by a court decision; - The Court Decision Enforcement Authority shall submit information of eligible voting citizen's whose serving imprisonment and/or detained for criminal case and/or receiving forced medical treatment and/or imprisoned for administrative offences; - The state administrative authority for border protection shall submit information of eligible voting citizens' who has travelled to a foreign country for 60 days or more; - The state administrative authority for border protection shall submit information of eligible voting citizens who are serving in their regiment or unit or staff in a soum or city district where they are not registered as permanent resident on the election day; - The state administrative authority in charge of defense shall submit information of eligible voting citizens who are serving in a military regiment or unit or staff in a soum or city district where they are 	Before 16 th August 2020

	<p>not registered as permanent resident on the election day;</p> <ul style="list-style-type: none"> - The police authority shall submit information of voters who are in detention for offences and those serving in domestic military regiment or unit or staff in a soum or city district where they are not registered as permanent resident; - The police authority shall submit information of voters who are detained and/or imprisoned for administrative offences; and - The state authority in charge of citizenship and migration shall submit information of citizens who acquired, restored or lost Mongolian citizenship in the year. <p>(Article 20.6 of the Local Election Law)</p>	
Party and coalition expressing their desire to participate in the election	<p>Branch offices of the party and coalition locating in the respective aimag, capital city, soum and capital city district representing the party and coalition and shall express its desire to abide by the Constitution of Mongolia, this law and other laws and shall submit request to participate in the local election to the respective election committees within at least 60 days before the election day.</p> <p>(Article 25.1 of the Local Election Law)</p>	Before 16 th August 2020
Candidate nomination	<p>A party or coalition registered to participate in local election shall start proposing a candidate 45 days before the election day and complete it for a seven-day period.</p> <p>(Article 28.1 of the Local Election Law)</p>	From 31st August 2020 until 06 th September 2020
	<p>Nomination of independents shall start 45 days prior to the election day and complete it for a seven-day period.</p> <p>(Article 28.2 of the Local Election Law)</p>	
Delivery of party and coalition's election platform assessment report	<p>The State audit high authority shall make assessment report of the party and coalition's election platform compliance to the requirements set forth in this law not less than 60 days prior to the election day and submit it to the respective election committees.</p> <p>(Article 37.10 of the Local Election Law)</p>	Before 16 th August 2020
Locations of campaign materials identified and publicly announced	<p>Locations of streets, squares, and public places in which an election campaign posters and advertising boards shall be defined by the Citizens' Representatives Hural of a soum or city district not less than 60 days prior to the election day and shall be publicly announced.</p> <p>(Article 40.3 of the Local Election Law)</p>	Before 16 th August 2020
